- 6) An email from Yasmin Arena-Foster, a neuroscientist with Clem June Centre neurobiology and Stem Cell Research Institute.


They have worked on spinal cord injuries where they've developed bridge technology using stem cells from the nose. With clinical trials beginning in the coming months.

ANNUAL GENERAL MEETING (14/10/2024)

An annual general meeting (AGM) is a meeting held once a year and all charity members are invited to attend. The purpose of an AGM is to give members a report on the charity's activities and finances for the previous year, to allow time for members to ask questions, and to elect members to the charity's governing body (the board or committee).

So how do we hold an effective AGM:

- 1. We use our 7 best (virtual) friends that's Who, Why, What, When, Which, Where and How to help us identify what we achieved in the last year and what we want to achieve this coming year (until the next AGM in October 2025).
- 2. This is the time that everyone of us speaks up to advise management and the committee the direction we want our support group to go. So if you're unable to attend the meeting please let Phil know asap by phone text or email what it is you want more of and less of for the next year.
- 3. Our governing document is our road map that we can use as a base to determine what it is we want. The governing document is available on our website https://pnsg.org.au. Click on document library tab at the top of the opening webpage and type any part of "governing document" into the search box. As the governing document was the last document that was uploaded then it appears on the top of the list of documents.

If you are using an iPad, the governing document will open and display on the screen. If you are using a computer (windows, I don't know how an Apple Mac handles it) it will download the governing document to your download folder. In both cases you will notice on our website that the document is split into two parts as it is too big for us to use in its one complete form.

Should you not have access to a computer, iPad or mobile phone and you wish a hard copy of our governing document then please let Phil R know immediately and he will discuss it with you.


